## CATEGORY PERFORMANCE:

Table Wine South Africa within MBLL represents a \$2.23 million annual portfolio, with \$ growth at (-0.11%), and a Litre growth at (-1.84%).

Primary category indicators are as noted below.

- ✓ Red Wine represents 56% of the category sales, generating a \$ growth of +3.98%
- ✓ White Wine represents 41% of the category sales, generating a \$ growth of (-4.16%)
- ✓ Rose' Wine represents 3% of the category sales, generating a \$ growth of (-12.86%)
- ✓ 750ml size format drives sales in the category, accounting for 77% of sales
- ✓ Premium Price Band (\$11.99 \$13.99) represents 77% of category sales

- ✓ Review CSR Product Listing Guidelines prior to submission (<u>NEW</u>)

Additional requirements if applicable:

- ✓ Declaration of Origin (Imported products)
- ✓ Annual Declaration of Production (new suppliers claiming Micro status)
- ✓ Product Sell Sheet (Optional)
