#### **CATEGORY PERFORMANCE:**

Sparkling Wine within MBLL represents a \$9.7 million annual portfolio, generating a dollar growth rate of +8.0%, and a litre growth rate of +5.2%.

- ✓ Prosecco represents 39% of category sales, with a \$ growth rate of +13.2%
- ✓ Cava represents 13% of category sales, with a \$ growth rate of (-0.5%)
- ✓ Champagne represents 13% of category sales, with \$ growth rate of +1.3%
- ✓ Other Sparkling Wine represents 35% of the category sales, with a \$ growth rate of +8.4%
- √ 750ml format is dominant size representing 94% of category sales
- ✓ In the 750ml format wines priced under \$25.00 represent 78% of sales, with a \$ growth rate of +9.4%

  - 1 image for MBLL Website (Bottle/can 3" wide at 300 dpi or case/package 5" wide at 300 dpi)
  - 1 image of Back/Side label –clear enough to review all label details
    - Please note: File share transfers (E.g. We transfers) will not be accepted
- ✓ Review CSR Product Listing Guidelines prior to submission
- ✓ Product must be CFIA (Canadian Food Inspection Agency) compliant

- ✓ Declaration of Origin (Imported products)
- ✓ Annual Declaration of Production (new suppliers claiming Micro status)
- ✓ Product Sell Sheet (Optional)
